As affiliated committees, Flippable (Federal) and Swing Left share contribution limits and can accept a combined total of up to \$5,000 per calendar year from an individual into their Contribution Accounts. By contributing here, you agree that the first \$5,000 of your contribution will be deposited in Swing Left's Contribution Account and the remainder in Swing Left's Non-Contribution Account.
